- 2. The expenditure involved will be met out from the Sanctioned budget under the function cum-object classification NC 21019 (015) "04-Economic Affairs-045-Construction & Transport-0452-Road Transport-045202 Highways/Roads and bridges during the current financial year.

- 5. As per decision of the Competent Authority dated 22-09-2015 that Road should not have less than 18 feet width except in built-up area or in the area where R.O.W is restricted and require acquisition of land.
- 6. This AA is valid for the CFY & no liability shall be created and will not be throw forward to next financial year and expenditure shall be restricted to the actual release of funds by Finance Department.
