- As per decision of the Competent Authority dated 22-09-2015 that Road should not have less than 18 feet 5. width except in built-up area or in the area where R.O.W is restricted and require acquisition of land.
- This AA is valid for the CFY & no liability shall be created and will not be throw forward to next financial 6. year and expenditure shall be restricted to the actual release of funds by Finance Department.
