All the bidding will be through E-bidding system. Technical bid should be in sealed envelope clearly marked as "TECHNICAL BID". Technical bids shall be submitted through courier before closing time for scheme.

Technical evaluation will be considered to the control of the courier before closing time for scheme.

Technical evaluation will be carried out on the basis of (General experience, Personal Capability, Equipment Capabilities & Financial Soundary of the School of Capabilities & Any Financial Soundness etc). Proper marking criteria as approved by competent Authority for the scheme will followed. Any bidder, who could'nt fulfill a scheme. bidder, who could'nt fulfill passing criteria shall be considered as fail leading to disqualification of the bidder for scheme, which may be collected from the office of undersigned on any working day.

As this is a concrete work @ ratio 1:1.5:3, therefore, that Contractor / firm will be eligible, who has concrete Batching Plant.

Technical Bids will be opened after 30 minutes of closing time in the presence of bidders/ their representatives who choose to be present for scheme

5. Financial electronic bids will be opened after the approval of Technical Bid from Competent Authority for scheme.

The Contractors quoting their bids more than 10% below upto 20% below on Engineer's Estimate shall submit along with their bids 8% Additional security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.

[Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineer's Estimate along detailed rate analysis]. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
