5. Each bidder shall prepare by filling out the forms completely and without alterations one (1) original and number of copies, specified in the Bidding Data. In the event of discrepancy between them, the original shall prevail.
6. The tie of rates amongst the bidders will be deemed under Section 31(a) & (b) of KPPRA Act 2012, i.e. the contract will be awarded to the best evaluated bid ascertained on the basis of total conformity to the evaluation criteria.

A set of documents containing Instructions to bidders for Single Stage Two Envelops procedure or any other information can be obtained by submitting written request on letter Pad of company/firm from the office of undersigned on any working day during office hours prior one day of bid submission on payment of a non-refundable fee of Rs.1000/-
