3. The bidders are required to send their bids through courier in duplicate in separate envelopes clearly marked as Original & Duplicate. The Original shall be sent to the **Executive Engineer C&W Division Bannu** and the Duplicate to **Superintending Engineer C&W Circle Bannu** Both the Original and Duplicate bids shall reach the concerned office before closing date and time.
4. BOQ Volume-I (except Tender Form) can be obtained from the office of the undersigned at office hours.

INSTRUCTIONS TO BIDDERS

(Pre-qualified contractors)

1. Tender Form should accompany the following:
 - a. Priced BOQ.
 - b. 2% Bid Security in the shape of deposit at call (original)
2. Incomplete/ Conditional / Telegraphic bids shall not be entertained. Bids shall be signed by authorized persons.
3. The contractor/bidders who quote their bids/rates more than 10% below the Engineer Estimate shall submit an Additional Security in the form of call deposit equal to 8% of the bid cost with financial bid. After commencement of work by the successful bidder 8% call deposit may be replaced with a bank guarantee of the same amount from the schedule bank.
4. The contractor/bidder will quote their bids/rates Above/Below system on BOQ based on MRS applicable.
5. The Additional Security will be released to the contractor in four installments i.e. 25% to be released after completing 25% of the project, 50% to be released upon 50% completion, 75% to be released upon 75% completion and the remaining amount to be released after completion of the project. In case the bidder quotes more than 10% below Engineer Estimate the bid is not accompanied by the Additional Security then the bid shall be considered as non-responsive and the 2nd lowest bidder and so on will be considered accordingly.
6. Complete bids (both original and duplicate) must reach the concerned offices on or before the fixed date/ time.
7. Any bidder who provides incorrect information should be disqualified.
8. Time allowed for completion of the work is as specified in the NIT which will start from the issuance of work order.
9. Bids will be valid for Ninety (90) days.
10. Successful Bidder should sign the agreement with the department within Seven (07) days after acceptance of bid.
11. Call Deposit of Scheduled Banks shall be acceptable.
12. If the evaluated bid costs of two or more than two bidders are same then the successful bid will be declared through draw.
13. Bids will be opened after 30 minutes of closing time in the presence of bidders/ their representatives who choose to be present.
14. The employer has the authority to reject any bid or all the bids assigning valid reasons.
15. Bid security of some or all the bidders will be retained by the employer till approval of Tender/ bid validity period.
16. All other terms / Conditions / documents can be seen in the office of the undersigned/consultant on any working day during office hours.
