

2. Tender Forms, BOQ and instructions to bidders (when there are bid documents) can be downloaded upto one day prior to the opening date from C&W website (www.cwd.gkp.pk).
3. Original Bid Security in the shape of Call Deposit in the name of Executive Engineer C&W Division Abbottabad shall accompany the financial bid. If any bid found without CD as prescribed, the bid shall be treated as **"Non responsive"** and the contractor shall be recommended to competent authority for debarring for onward tendering.
4. According to Provincial Government Notification No. KPPRA /M&E/Estt:/1-5/2016 dated 24/05/2016 the Contractors/Bidders who quote their bids/rates more than 10% below the Engineer's Estimate shall submit an Additional Security in the form of call deposit equal to 8% of the bid cost. After commencements of work by the successful bidder 8% call deposit may be replaced with a bank guarantee of the same amount from the scheduled bank.
5. The additional security shall be released to the contractor in four installments i.e. 25% to be released after completing 25% of the project, 50% to be released upon 50% completion, 75% to be released upon 75% completion and the remaining amount to be released after completion of the project. In case the bidder quotes more than 10% below the tender cost (Engineer's Estimate) and the bid is not accompanied by the additional security then the bid shall be considered as **"Non-responsive"** and the 2nd lowest bidder and so on will be considered accordingly.
6. The Contractors/firms shall quote their rates on **ABOVE / BELOW SYSTEM** as all tenders shall be processed according to above/below system on BOQ based on MRS-2016.
7. The bidders are required to send their bids through courier in duplicate in separate envelopes clearly marked as Original & Duplicate and then sealed in One Envelope be sent to the Executive Engineer C&W Division Abbottabad. Tender Forms shall reach in the office of undersigned before closing date and time.
8. A pre-bid meeting will be held in the office of undersigned five days before the submission date of bids.
9. Complete set of Bid Documents (except Form of Bid and BOQ) can be purchased from the office of undersigned.
