
**INVITATION FOR BID**

2. Tender form and BOQ can be downloaded upto one day prior to the opening date from C&W website ([www.cwd.gkp.pk](http://www.cwd.gkp.pk)).
3. Original bid security in the shape of call deposit in the name of Executive Engineer Provincial Building (Construction) Division-I Peshawar, shall accompany with the bid.
4. The bidders are required to send their bids through Courier in duplicate in separate envelopes clearly marked as original and duplicate. The original shall be sent to the Executive Engineer Provincial Building (Construction) Division-I Peshawar, and the duplicate to Superintending Engineer Provincial Building (Construction) Peshawar. Both Original and duplicate bids shall reached the concerned office before closing date and time.
5. The contractors / bidders who quote their bids/rates more than 10%below the engineering estimate shall submit an additional security in the form of call deposit equal to 8%of the bid cost. After commencement of works by the successful bidders 8% call deposit may be replaced with a bank guarantee of the same amount from the scheduled bank.
6. The additional security shall be released to the contractor in four installments i.e. 25% to be released after completion 25% of the project, 50% to be released upon 50% completion, 75% to be released upon 75% completion and the remaining amount to be released after completion of the project. In case the bidder quotes more than 10%below the bid cost and the bid is not accompanied by the additional security then the bid shall be considered as non-responsive and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly vide KPPRA Notification No.KPPRA/M&E/Estt. / 1-5/2016 dated 24.05.2016.

7. The tenders shall be processed according to “above / below system” based on the Market Rate System.
8. A complete set of Bidding Documents may be obtained by an interested eligible bidder on submission of a written application from the office of undersigned in the working hours one day prior of submission of form/documents, otherwise his bid will not be entertained.
