The bidders should be registered with Pakistan Engineering Council (PEC) in relevant category and field of specialization, enlisted with C&W Department and should have adequate financial soundness, relevant experience, personnel capabilities, require equipment and others as included in ITB.

5. Each bidder shall prepare by filling out the forms completely and without alterations one (1) original and number of copies, specified in the Bidding Data. In the event of discrepancy between them, the original shall prevail.
6. The tie of rates amongst the bidders will be deemed under Section 31(a) & (b) of KPPRA Act 2012, i.e. the contract will be awarded to the best evaluated bid ascertained on the basis of total conformity to the evaluation criteria.
