RIGHTS COLLECTION FOR THE YEAR 2019**

Pakhtunkhwa Highways Authority, Government of Khyber Pakhtunkhwa invites sealed bids for collection of toll tax for the following Toll station from interested operators having valid PEC Registration in the operators category O-6 or above and enlisted with PKHA or Any other individual registered with Income Tax Department and Khyber Pakhtunkhwa Revenue Authority (KPRA), can participate in the auction after depositing registration fee of Rs. 20,000/- for the current contracts only.

- The bidders will have to submit Earnest Money, Cost of Tender Form accompanying Additional Security as mentioned above along with bid in shape of call deposit in favour of Managing Director Pakhtunkhwa Highways Authority Peshawar, from a scheduled Bank of Pakistan payable in Peshawar Branch, failing which, bid will not be entertained.
- Bidders who were awarded contracts of previous year Toll Tax Collection Rights, will have to submit a certificate from the concerned Deputy Director PKHA regarding satisfactory performance with their bids. In case of failure their bids will not be processed further.
- Bidders who have not cleared income tax or other payable amounts in connection with previous bids, will not be eligible in participating till payment of the mentioned outstanding amount before the closing date.
- Sealed bids are required to be sent through courier / urgent mail service (UMS) upto **12:00 noon of 28-11-2018**, which will be opened the same day at **12:30 pm** in the presence of the participants or their representatives.
- If connivance, pooling, ring or any kind of graft is reported, then the bid will be cancelled and the bidder will be black listed.
- The auction will be held in camera under video recording.
- The successful bidder will have to deposit all Government taxes on prescribed rates fixed time to time by Government, of the bid cost within 7 days of the approval of the bid. Otherwise, the bid will be cancelled.
- The procuring entity may reject all bids at any time prior to the acceptance of a bid. The procuring entity shall upon request, communicate to any contractor who submitted a bid, the grounds for rejection of all bids.
- The Bidders should be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA).
