- 3. The Administrative Approval does not constitute any sanction to rates provided in the rough cost estimate. The financial responsibility of the rates rests with the authority competent to accord technical sanction to the cost estimate.
- 4. The sanctioning authority shall allow appropriate rates after observing all codal formalities/standing instructions regarding schedule of rates and financial regularity. The work shall be taken in hand after release of funds and proper technical sanction of the cost estimate.
