SUBJECT: ADMINISTRATIVE APPROVAL FOR THE SCHEME "CONSTRUCTION/REHABILITATION OF ROAD NETWORK IN DARRA ADAM KHEL (AIP) AIP, ADP NO.1948/200292 (2020-21)

In exercise of the powers delegated vide Part-I Serial No.5 Second Schedule of the Delegation of Powers under the Financial Rules and Powers of Re-appropriation Rules, 2018, the Khyber Pakhtunkhwa Provincial Government is pleased to accord the Administrative Approval for the implementation of the scheme under ADP No.1948/200292 (2020-21) "Construction/rehabilitation of road Network in Darra Adam Khel (AIP)" for the period of 20 months from (2020-21) to (2021-22) at a total cost of Rs.229.741 million (Rupees Two hundred twenty nine million & seven hundred forty one thousand only) as per detail given below:-

1. The scheme was approved by the PDWP meeting held on 22.10.2020. Minutes forwarded by P&D Department letter No. Chief/INF/P&D/170-01/2020/3098-3115 dated 27.10.2020.
2. The expenditure involved will be met out from the Sanctioned budget under the function cum-object classification 01-General Public Services-019-General Public Services Not Elsewhere Define-01091-General Public Services Not Elsewhere Define-019120-Others NC12069(060).
3. The Administrative Approval does not constitute any sanction to design rates provided in the rough cost estimate. The suitability of design & financial responsibility of the rates rests with the authority competent to accord technical sanction to the cost estimate.
4. The sanctioning authority shall allow appropriate rates after observing all codal formalities/ standing instructions regarding schedule of rates and financial regularity. The work shall be taken in hand after release of funds and proper technical sanction of the cost estimate.
5. As per decision of the Competent Authority dated 22-09-2015 that Road should not have less than 18 feet width except in built-up area or in the area where R.O.W is restricted and require acquisition of land.
