In exercise of the powers delegated vide Part-I Serial No.5 Second Schedule of the Delegation of Powers under the Financial Rules and Powers of Re-appropriation Rules, 2018, the Khyber Pakhtunkhwa Provincial Government is pleased to accord the Administrative Approval for implementation of the "AOM&R to all Roads in District Mansehra 2023-24" for CFY at a total cost of Rs.40.000 million (Rupees Forty million only) as per detail given below:-

- The scheme was approved by the DDWP/DSC in its meeting held on 03.08.2023. Minutes circulated by C&W Department vide No.SOR/3-4/G-MTG/C&W/2023, dated 01.09.2023.
- The expenditure involved will be met out from the Sanctioned budget under the function cum-object classification NC 21019 (015) "04-Economic Affairs-045-Construction & Transport-0452-Road Transport-045202 Highways/Roads and bridges during the current financial year.
- The Administrative Approval does not constitute any sanction to design rates provided in the rough cost estimate. The suitability of design & financial responsibility of the rates rests with the authority competent to accord technical sanction to the cost estimate.
- The sanctioning authority shall allow appropriate rates after observing all codal formalities/ standing instructions regarding schedule of rates and financial regularity. The work shall be taken in hand after release of funds and proper technical sanction of the cost estimate.
- As per decision of the Competent Authority dated 22-09-2015 that Road should not have less than 18 feet width except in built-up area or in the area where R.O.W is restricted and require acquisition of land.
- This AA is valid for the CFY & no liability shall be created and will not be throw forward to next financial year and expenditure shall be restricted to the actual release of funds by Finance Department.
