**SUBJECT: REVISED ADMINISTRATIVE APPROVAL FOR THE SCHEME "RESTORATION/REHABILITATION OF DAMAGED REACHES DUE TO UTILITY LINES IN VARIOUS ROADS IN DISTRICT SWAT (DEPOSIT WORK)".**

In exercise of the powers delegated vide Part-I Serial No.5 Second Schedule of the Delegation of Powers under the Financial Rules and Powers of Re-appropriation Rules, 2018, the Khyber Pakhtunkhwa Provincial Government is pleased to accord the Revised Administrative Approval for the implementation of the scheme under Deposit work "**Restoration/Rehabilitation of damaged reaches due to utility lines In various roads in District Swat.(Deposit Work)**" for financial year (2020-21) at a total cost of Rs. 34.090 million (Rupees Thirty four million & ninety thousand only) as per detail given below:-

2. The expenditure involved will be met out from the Sanctioned budget under the function cum-object classification G10-Trust Accounts other G101-Accounts of other departments, G10113-Public Works Deposit.  
**No funds will be required as funds are available with Executive Engineer under PW/Deposit from road cutting.**
3. The Administrative Approval does not constitute any sanction to design/ rates/prices provided in the rough cost estimate/escalation. The financial responsibility of the rates & suitability of design rests with the authority competent to accord Technical sanction to the cost estimate.
4. The sanctioning authority shall allow appropriate rates after observing all codal formalities/standing instructions regarding schedule of rates and financial regularity. The work shall be taken in hand after release of funds and proper technical sanction of the cost estimate.
5. This AA is valid for the CFY (2020-21) & no liability shall be created and will not be throw forward to next financial year and expenditure shall be restricted to the actual release of funds by Finance Department.
