 - As recommended by Sub Committee of the Cabinet notified vide Section Officer (Confidential) Chief Minister's Secretariat Khyber Pakhtunkhwa Peshawar No. SO(C)/CMS/KPK/2021/2828-21 Dated: 05.04.2021. Non Refundable Bidding Entry fee @0.03% of Tender Cost alongwith 02% Earnest Money and stamp Duty separately (In Original) should accompany the financial Bid.
- The bidders should be enlisted with Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
- A copy of the technical proposals in the required format is mandatory and to be uploaded as part of E-Bidding before submitting financial bids.
- 5. Scanned copy of bid Security shall be submitted electronically alongwith technical bid on E-Bidding system.
- 6 Date of opening of financial bid will be intimated to successor bidder after approval of technical bid.
- 7 Venue of Bid opening is C&W Division Hangu.

- The Contractors quoting their bids upto a limit of 10% below Engineer Estimate shall submit bid security @2% only of Engineer Estimate.
- The Contractors quoting their bids more than 10% below upto 20% below on Engineer's Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
- Similarly, a Contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineer's Estimate alongwith detail rate analysis. In case of more than 20% below bids, if the bid not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted alongwith such non responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
- In case detailed rate analysis submitted with the bid is, in view of the procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
- Technical Bid should accompany affidavit regarding declaration that Bid / Additional Security in the shape of deposit at call (original) has been enclosed in financial bid.
- After commencements of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank; if the already deposited security is not the form of bank guarantee.
- 15. Any bidder who provides incorrect information shall stand disqualified and will be debarred.

- 17. Bid security 1st, 2nd and 3rd bidders will be retained by the employer till approval of bid
