- 2- The bidders should submit their E-bids as per KPPRA Notification No. SOR(13)/Vol:1-24/2021-22, dated 10-05-2022.
- 3- A copy of Technical Proposal in the required format is mandatory and to be uploaded as a part of E-bid before submitting financial bid.
- 4- The bidder shall in addition, place an affidavit in the technical proposal stating that a bid security amounting to 2% without indicating the figure in the letter, has been placed in the financial proposal or bid. Otherwise the technical proposal will be considered non-responsive and will be returned to the bidder after being examined by the procurement committee.
- 5- Original Copies of Call Deposits for Bid Security and Bidding Entry Fee should be enclosed in the Technical Proposal and shall reach to the office before closing time.
- 6- Legible scanned copy of bid security shall be submitted electronically along with the bid on E-Bidding System.
- 7- All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority under Finance Act, 2013 Act No. XXI of 2013 and must be active tax payer.
- 8- Venue of Bids opening is office of the Executive Engineer C&W Division Torghar.
