The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.

4- All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in Schedule-II of the Act ibid.

5. Technical Proposal should be accompany the following:
- i. Bid Security 2% of the Estimated Cost in the shape of call deposit in (original) enclosed in technical proposal.
6. In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder **only** to the extent of bid more than 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
- j. Enlistment Order of C&W Department (photocopy)
 - k. Renewal of registration for CFY 2020-21 (Photocopy).
 - q. National Identity Card (CNIC Photocopy)
 - r. Valid Pakistan Engineering Council registration copy for current calendar year.
 - s. Form-H of the company/Firm.
 - t. Documents showing general capabilities, financial soundness, general and relevant experience record, personnel capabilities, equipment capabilities & Income Tax/NTN Certificates, etc.
 - u. Any other document to support the technical bid.
7. After commencements of work by the successful bidder, the additional security shall be released to the bidders in four installments i.e.25% to the project and so on.
8. All the bidding will be through E-Bidding System. Technical bid should in sealed envelopes clearly marked "Technical Bid" **Technical bids shall be submitted through courier before closing time.**
9. The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as non MRS items.
10. Technical Evaluation will be carried out on the basis of (General experience, Personal Capability, Equipment Capabilities & Financial Soundness etc.) proper marking criteria as approved by Competent Authority. Failing to fulfill passing criteria shall be considered as fail leading to disqualification of the bidder.
11. Financial bid shall be filled online. Complete bids must reach the concerned offices on or before the fixed date/time. **The CDR shall be enclosed in the Technical proposal.**
12. Any Electronic Bidder who provides incorrect information shall stand disqualified & de-barred.
13. Time allowed for the completion of the work as specified in the NIT shall start form the issuance of LOA.
14. Electronic Bids validity period is 90 days.
15. Successful Bidder should sign the agreement with the department within Twenty Eight (28) days after issuance of LOA
16. **The bid security shall be submitted from the account of the firm / bidder / contractor who submits the bids from schedule bank.**
17. If the evaluated electronic bid costs of two or more the two bidders are equal then the successful be will be declared through draw.
Technical Bids will be opened after 30 minutes of closing time in the presence of bidders/their Representatives who choose to be present.
18. Financial electronic bids will be opened on after approval of Technical Evaluation.
19. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
