1. Fulfillment of all codal & financial formalities.
2. The Executive Engineer/Sub Divisional Officer incharge are responsible for the execution of the work according to the specifications, scope of work provided in administratively approved.
3. The work may be completed within stipulated period and technical sanction from the competent authority must be obtained before commencement of the work. The work order shall only be issued after fulfillment of all codal formalities.
4. The contractor may be directed to sign the contract agreement before commencement of the work and be asked to submit work plan immediately, for approval of the XEN.
5. The Executive Engineer while issuing the work order will also specify the quarry/sources of the basic materials to the contractor so as to ensure good quality of the work.
6. Professional tax/income tax and stamp duty shall be recovered from the contractor as per rules.
7. The Procurement Committee shall be responsible for correctness and validity of the Contractor's enlistment with the Department & PEC and transparency of bidding.
8. Each payment will be supported by Material Test Result. A test profile may be maintained for the project.
9. In case of Non Scheduled Items are provisionally approved subject to the condition that the rates of Non Scheduled Items shall be approved by the competent authority under relevant clause of Contract Agreement before issuance of work order.
10. Additional Security shall be deposited by the contractor in shape of call deposit as per KPPRA Notification No. KPPRA/M&E/Estt:/1-17/2019-2020 dated 12.06.2020 before issuance of work order.
11. Procurement Committee shall be responsible for the verification of call deposit, additional security and performance guarantee etc.
