The bidders will have to submit Earnest Money, Registration Fee accompanying Additional Security as mentioned above along with bid in shape of call deposit in favour of Managing Director Pakhtunkhwa Highways Authority Peshawar, from a scheduled Bank of Pakistan payable in Peshawar Branch, failing which, bid will be considered as **"Non-Responsive"**.
4. Bidders who were awarded contracts of previous year Toll Tax Collection Rights, will have to submit a certificate from the concerned Deputy Director PKHA regarding satisfactory performance with their bids. In case of failure, the bids will be considered as **"Non-Responsive"**.
5. Bidders who have not cleared income tax or other payable amounts in connection with previous bids, up till the deadline for submission as mentioned in the above table will be considered as **"Non-Responsive"**.
6. The Bidders should be registered with Khyber Pakhtunkhwa Revenue Authority (KPRRA) (Active Status).
7. The bidder will submit the Financial Bid and other documents in 2 separate envelopes. 2% bid security, additional security & Registration Fee, shall be sealed in one envelope clearly marked as "Bid Security" and shall be put in one envelope and other documents in another envelope failing which the bid will be considered as **"Non- Responsive"**.
8. Sealed bids with sticking tap (not with stapler) of courier or by bidder however, the openable, face should be fully covered by sticking tap to make the envelope sealed. Any lapse in this regard will make your bid, **"Non-Responsive."** bids are required to be sent through courier / urgent mail service (UMS) upto **12:00 noon** of **16-11-2020**, which will be opened the same day at **12:30 pm** in the presence of the participant bidders or their representatives.

9. If convince, pooling, ring or any kind of graft is reported, then the bid will be cancelled and the bidders will be debarred.
10. The auction will be held in camera under video recording.
11. The successful bidder will have to deposit all Government taxes on prescribed rates fixed time to time by Government, of the bid cost within 7 days of the approval of the bid. Otherwise, the bid will be cancelled and the bid security will be forfeited in the favour of Government.
12. A Pre-bid meeting will be held in office of the undersigned on **09/11/2020 at 11:00** AM for clarification of bidding documents / evaluation criteria or other related information regarding the work.
13. The procuring entity may reject all bids at any time prior to the acceptance of a bid. The procuring entity shall upon request, communicate to any contractor who submitted a bid, the grounds for rejection of all bids.
