- II. A firm / joint venture will be selected for the services under quality cum cost based selection (QCBS) method as per procedure / criteria described in the request for proposal (RFP) documents.

You are invited to submit a comprehensive Technical proposal in English (Original + one copy) and a financial proposal (Original + one copy) for the services required under the terms of references (TOR's) latest by 14 / 12 / 2020 till 12:00 Noon which will be opened on the same day at 12:30 P.M. The original & copy of the proposal shall be sealed in separate envelopes and marked as original and copy. Both these envelopes shall be put in one sealed envelop and addressed to Managing Director PKHA.
- IV. RFP documents / TOR's are available in the office of the undersigned and can be obtained on payment of Rs. 1000/- (non-refundable) in form of CDR on any working day during office hours.
