2. Proposal shall contain but not limited to the following:

- A letter of intent addressed to Managing Director-PKHA.
- The title page of brochure shall also contain the nomenclature of the work for which the bidder intends to apply.
- Complete profile of the company with perfect binding (wire / spiral binding, loose binding shall be avoided).
- Detail of similar nature works completed during last 05-years supported by completion certificates and work orders of Executing agencies concerned.
- Detail of Machinery (Tools, Plants & Equipments etc) supported with the purchase document / registration of regulatory Department concerned.
- Particulars of technical staff & engineers and their agreement on stamp paper with the firm together with their qualification. Affidavit to the effect that the said personnel or their equivalent shall be made available for the job should also be given alongwith their registration number of PEC (In case of graduate engineer).
- Financial soundness supported by annual audit reports for the latest year.
- Affidavit regarding non involvement in litigation and non-blacklisting of firm.
- Detail of litigation and arbitration cases (if any) in which the contractor / firm involve.
- Income Tax return certificate for latest year.
- In case of JV of contractors all the firms must have valid KPRA registration. The firms must have the required PEC Category mentioned above and the relevant specialized codes.
- Any other document or information, which is considered necessary for pre-qualification.

3. A set of pre-qualification documents (including inter alia evaluation criteria, instruction for preparation of firm's brochure and list of documentary evidence required for pre-qualification) are available in the office of undersigned and can be obtained on any working day during office hours on Call Deposit in the name of Managing Director-PKHA of Rs.1000/- (non-refundable) against each package. These documents can also be downloaded from the official web site of PKHA whereas a Call Deposit of Rs.1000/- (non-refundable) on account of fee of the documents against each package shall be annexed with application failing which the application will not be considered.

4. Separate proposal sealed in separate envelope should be submitted against each package.

5. Sealed proposal should reach the undersigned upto 12:00 Noon on **14 / 12 / 2020** through postal services, which will be opened on the same date at 12:30 P.M.
