2. All bidders are required to register with Khyber Pakhtunkhwa Revenue Authority, Established under Khyber Pakhtunkhwa Finance Act 2013 (Khyber Pakhtunkhwa XXI of 2013) for works consulting and Non consulting services as listed in Schedule – II of the Act *ibid*.
3. Original Bid Security in the shape of call deposit in the name of Executive Engineer C&W Highway Division Swat shall accompany the financial bid.
4. According to KPPRA Notification issued vide No. KPPRA/M&E/Estt:/1-17/2019–20, dated: 12.06.2020.
 - a. In Case of bid / rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder *only* to the extent: of bid more than 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
 - b. In such eventuality, the successful bidder shall be bound to produce the additional bid security within three (03) working days from the issuance of Letter of Acceptance failing which the procuring entity shall forfeit the bid security of successful bidder and may also initiate legal proceeding against the bidder who repudiated the contract under KPPRA procurement rules.
