## **INSTRUCTIONS TO BIDDERS (ITB)**

1. Financial proposal should accompany the following:
  - a. Original Bid Security (2% of Engineer Estimate) in the shape of call deposit (Non-Refundable) in the name of Managing Director-PKHA, Peshawar shall accompany the bid.
  - b. In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the Engineer's estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
  - c. The successful bidder shall be bound to provide the Additional Bid Security within 3 working days from the issuance of Letter of Acceptance, failing which the procuring entity shall forfeit the bid security of successful bidder and may also initiate legal proceeding against the bidder who repudiated the contract under KPPRA procurement rules. The procuring entity may offer the contract to next lowest bidder covered by the KPPRA notification.
  - d. The bidders are required to quote their rates (electronically) "ABOVE / BELOW / AT PAR" for both priced BOQ / Engineer Estimate based on MRS-2019 and NSI Items as well. Only two digits after the decimal point shall be considered for evaluation purpose.
2. All other items not mentioned in the BOQ but exist in the MRS-2019 shall be paid at contractor's rate approved by the Competent Authority with approved area cost factor.
3. Successful bidder shall have to install asphalt batch plant & concrete batch plant in close vicinity of the respective site and relevant charges shall deem to be included in the rate quoted.
4. The Successful bidder shall be subjected to all admissible taxes including stamp duty, service charges, sale tax and any other at prevailing rate.
5. Financial bid shall be filled online. Complete bid must reach this office on or before the fixed date time.
6. Time allowed for the completion of the work as specified in the NIT shall be started from the Date of commencement as directed by the Engineer In charge.
7. Electronic Bids validity period is 90-days.
8. Successful Bidder should sign the agreement with PKHA within Twenty-Eight (28) days after issuance of Work Order.
9. Call Deposit and bank guarantee of Scheduled Banks shall be acceptable from the Contractor firm.
10. If the evaluated electronic bid costs of two or more than two bidders are equal, then the successful bid will be declared through open draw.
11. The Procuring Entity has the authority to reject any E-bid assigning cogent reasons.
12. Bid security of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders for the specific work will be retained by the Authority till the approval of bids.
13. Complete set of Bid solicitation documents can be downloaded from PKHA web site ([www.pkha.gov.pk](http://www.pkha.gov.pk)) and can also be obtained from the office of Deputy Director (HQ) PKHA, Peshawar at a cost of Rs. 8,000/- only and submit it along with the Bid otherwise bid will be considered as Non-Responsive.
