- The Bidders who submitted their financial bids without a valid Call Deposit will be debarred from participating in bidding process for one year.
- The bidders should be enlisted with Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
- A copy of the technical proposals in the required format is mandatory and to be uploaded as part of E-Bidding before submitting financial bids.
- Scanned copy of bid Security shall be submitted electronically alongwith technical bid on E-Bidding system.
- Date of opening of financial bid will be intimated to successor bidder after approval of technical bid.
- Venue of Bid opening in C&W Division Hangu.
- In case of bid / rate quoted by the bidder more than 10% below Engineer estimate, the successful bidder shall be bound to produce the additional bid security within three (03) working days failing which the bid security will be forfeited and offer be given to next lowest bidder and legal action will be initiated against the bidder as per KPPRA notification dated 12<sup>th</sup> June 2020. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below Engineer Estimate.
