

- Bidders who submitted their financial bids without a valid Call Deposit will be debarred from participating in bidding process.
- Bid Security 2% of the Estimated Cost in the shape of call deposit in (original) enclosed along-with bidding documents.
- In case of bid/rate quoted by the bidder is more than 10% below Engineer estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the Engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below Engineer estimate. In such eventuality, the successful bidder shall bound to produce the additional bid security within three (03) working days from the issuance of letter of acceptance failing which the procuring entity shall forfeit the bid security of successful bidder and may also initiate legal proceeding against the bidder who repudiated the contract under KPPRA procurement rules.
- All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services a listed in Schedule-II of the Act ibid.
- Venue of bids opening is office of the Executive Engineer C&W Tribal Division Darra Adam Khel / Hassan khel at Kohat.
- The Bidder should have the relevant PEC specialization code, without which the bid will not be acceptable.
