NOTICE RE-INVITING E-BIDDING.


(Single Stage Two Envelops E-bidding System).

The C&W Department office of the **Executive Engineer C&W Building Division-I Peshawar** Government of Khyber Pakhtunkhwa Invites Electronic Bids from the eligible Firms / Bidders in accordance with KPPRA Procurement Rules 2014 on "Single Stage Two Envelops Procedure" for the below works. The bidders should be Registered with Pakistan Engineering Council (P.E.C) for the Year 2019-20 in Relevant Category & field of specialization, Enlisted with C&W Department.


1. Bid documents including instruction to bidders and BOQ can be downloaded up to one day prior to the opening date from C&W Web Site (www.cwd.gkp.pk).
2. A complete set of Bid Solicitation Documents may be obtained on submission of a written application one day prior to the opening date from office of the undersigned otherwise bids submitted without these documents will not be processed for post qualification.
3. **In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the Engineer Estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below Engineer Estimate.**
4. The Contract will be awarded to the bidder under Section 28(e) of the KPPRA Act,2012 whose bid is responsive and is determined as the best evaluated bid as defined in Section2(1)(c)(ii) of the Act ibid.
5. All Bidders are required to be Registered with the Khyber Pakhtunkhwa, Revenue Authority, Established under the Khyber Pakhtunkhwa, finance act, 2013 (Khyber Pakhtunkhwa, Act No. Xxi of 2013), for works, Consulting and Non-Consulting Services as listed in schedule-ii of the act ibid, with Pakistan Engineering Council (PEC) and KPPRA.

SINGLE STAGE TWO ENVELOPS E-BIDDING SYSTEM INSTRUCTION TO BIDDERS.

1. All the bidders shall submit online Technical bid through E-bidding system. No bid shall be entertained who didn't submit his online Technical Bid and his bid shall be considered non-responsive.
2. The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as Non-schedule items.
3. Technical evaluation will be carried out on the basis of (General experience, Personal Capability, Equipment Capabilities & Financial Soundness etc.) proper marking criteria as approved by Competent Authority. Failing to fulfill passing criteria shall be considered as fail leading to disqualification of the bidder.
4. Financial bid shall be filled online. Complete bids must reach the concerned offices on or before the fixed date/ time. **The C.D.R or additional security in the shape of call deposit (if required) shall be enclosed in sealed envelope in the Financial Bid Proposal.**
5. Any Electronic Bidder who provides incorrect information shall stand disqualified & de-barred.
6. Electronic Bids validity period is 90 days.
7. Successful Bidder should sign the agreement and specifications with the department within Twenty Eight (28) days after issuance of L.O.A.
8. Call Deposit of Scheduled Banks shall be acceptable.
9. Technical Bids will be opened after 30 minutes of closing time in the presence of bidders/ their representatives who choose to be present.
10. Financial electronic bids will be opened after approval of Technical Bid from Competent Authority.
11. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
12. Bid security of the 1st, 2nd and 3rd lowest Electronic Bidder for the specific work will be retained by the Department till the approval of bids.
13. The Procurement Committee shall be responsible for the Authenticity/verification of CDRs of all the participated bidders (Pay Order will not be acceptable as per KPPRA Rules).
14. Pay Order is hereby non-acceptable bid vide KPPRA Notification No.KPPRA/M&E/Estt:/1-12/2017-18 dated 05-04-2018.
15. **The Sub Clause 16.5 of Clause IB. 16 of Instruction to Bidders of the Standard Bidding Documents for Procurement of Small Works a Bid determined as substantially non-responsive will be rejected and will not subsequently be made responsive by the bidder by correction of the non-conformity.**
16. The Procuring Entity will be declare those firms non-responsive those do not fulfill the terms and conditions of the Procuring Entity set forth in the tender notice and bid solicitation documents.
