C & W Department (C&W Division, Bannu), Government of Khyber Pakhtunkhwa invites electronic Bids from eligible firms /contractor in accordance with KPPRA procurement rules 2014 on single stage single envelop procedure for the following works.

Bid documents and instruction to bidders can be downloaded from C&W web site (www.cwd.gkp.pk) before the submission date/time.

- a. Bid security 2% of the estimated cost in shape of call deposit (in Original) should be enclosed along with bidding documents.
- b. In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
- c. In such eventuality, the successful bidder shall be bound to produce the additional bid security within three (03) working days from the issuance of letter of Acceptance failing which the procuring entity shall forfeit the bid security of successful bidder and may also initiate legal proceeding against the bidder who repudiated the contract under KPPRA procurement rules.
- d. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids and the market analysis in order to discourage cartel making and to protect public interest at large.
- e. The bidder must be enlisted with the Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
- f. Pay Order is not acceptable as per Notification No. of KPPRA vide No. KPPRA/M&E/Estt/1-12/2017-18, dated: 05/04/2018.
- g. Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bids.
- h. The Khyber Pakhtunkhwa Finance Act XXVII of 2019 2nd Schedule under S.No.14, in case of projects funded under the Government's ADP Budget, Tax shall be charged at the rate of Two Percent (2%).
- i. Venue of bids opening is office of the Executive Engineer, C&W Division Bannu.
