You are invited to submit a comprehensive Technical proposal in English (Original + one copy) and a financial proposal (Original + one copy) for the services required under the terms of references (TOR's) latest by 25 / 02 / 2021 till 12:00 Noon which will be opened on the same day at 12:30 P.M. The original & copy of the proposal shall be sealed in separate envelopes and marked as original and copy. Both these envelopes shall be put in one sealed envelope and addressed to Managing Director PKHA.
