2. Bid documents and instruction to bidders can be downloaded up to the opening date from C&W web site (www.cwd.gkp.pk).
3. Bid security 2% of the estimated cost in shape of call deposit (in Original) be enclosed alongwith bidding documents & No pay order will be accepted. CDR from contractors own bank account will be accepted.
4. In case of bid / rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
5. In such eventuality, the successful bidder shall be bound to produce the additional bid security within three (03) working days from the issuance of letter of acceptance failing which the procuring entity shall forfeit the bid security of successful bidder and may also initiate legal proceeding against the bidder who repudiated the contract under KPPRA procurement rules.
6. All bidders are required to be registered with Khyber Pakhtunkhwa revenue authority for works, consulting and non-consultingservices as listed in schedule-II of the Khyber Pakhtunkhwa Finance Act, 2013 Act No.XXI of 2013".
