2. Bid documents and instruction to bidders can be collected from the office of the undersigned on any working day OR download from C&W web site (www.cwd.gkp.pk) before the submission date/time.
- Bid security 2% of the Estimated cost in shape of call deposit (in Original) be enclosed along with bidding documents.
 - In case of bid/rate quoted by the bidder more than 10% below on engineer estimate, the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
 - In such eventuality, the successful bidder shall be bound to produce the additional bid security within three (03) working days from the issuance of letter of Acceptance failing which the procuring entity shall forfeit the bid security of successful bidder and may also initiate legal proceeding against the bidder who repudiated the contract under KPPRA procurement rules.
 - Bidders who submitted their financial bids only with a valid call deposit will be considered for participation in bidding process.
 - A copy of the Financial proposals in the required format is mandatory and to be uploaded as a part of E-Bidding System.
 - The bidder must be enlisted with the Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
 - Venue of bids opening is **office of the Executive Engineer, C&W Tribal Sub Division Wazir/Bhattani at Bannu.**
