



4. Bid security of the estimated cost in the shape of call deposit (in original) should be enclosed along with bidding documents.
5. In case a bidder quoted bid rate more than 10% below Engineer Estimate , he shall be bound to produce an additional bid security to the extent of bid more than 10% below the engineer estimate in the form of percentage> The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below on engineer estimate.
6. Only the successful bidder shall be bound to produce the additional bid security within 03 (Three) working days from the issuances of letter of acceptance failing which already submitted 2 % Bid security will be forfeited and legal action will also be initiated against the defaulter as per KPPRA Procurement ruels.
7. All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance act 2013( Khyber Pakhtunkhwa act No.XXI of 2013 ) for works consulting and non consulting services a listed in schedule II of the Act ibid.
8. If the evaluated electronic bid cost of the two or more than Two bidders is equal then the successful bid will be declared through draw.
9. Venue of bids opening is office of the executive Engineer C&W Division Tribal District Mohmnad.
