**TERMS AND CONDITIONS**

1. Bid Soliciting Document containing Instruction to Bidders, advertisement for Notice inviting Bids and required forms to be filled by the bidders can be downloaded from the official website of C&W Department Khyber Pakhtunkhwa [www.cwd.gkp.pk](http://www.cwd.gkp.pk)
2. Electronic bidding shall be done on "Above/Below System: on BOQ/Engineer's Estimate. Based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
3. The Bidder should submit through courier and 2% Security sealed in envelope of the Engineer Estimated in the shape of Call Deposit (Original) before closing date & time.
4. In case of Bid / Rate quoted by the Bidder more than 10% Below the Engineer's Estimate the Additional Bid security shall be sought from the successful Bidder only to extent of bid more than 10% Below the Engineer's Estimate in the form of percentage. The Amount of Additional Bid Security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% Below Engineer's Estimate.
5. In such eventually, the successful bidder shall be bound to produce Additional Bid Security within 03 working days from the issuance of letter of Acceptance, failing which the procuring entity shall forfeit the Bid Security of the successful Bidder and may also initiate legal proceeding against the bidder who repudiates the contract under KPPRA Procurement Rules.
6. All the Bidders are bound to follow the instructions content KPPRA Notifications No. KPPRA/M&E/Estt:/1-17/2019-20. Dated 12-06-2020.
7. Scanned copy of 2% call deposit shall be submitted electronically on or before the fixed date / time.
8. Any Bidder who provides incorrect information shall stand disqualified and will be debarred.
9. Call Deposit of schedule Banks shall be acceptable and no Bank Cheque or pay order shall be acceptable.
10. Bidders shall provide copy of CNIC. Enlistment. PEC Registration and KPPRA Registration.
11. The Competent Authority reserves the right to accept or reject any or all bids at any time prior to acceptable of a bid as per Para 47(1) of KPPRA Rules 2014.
12. Bid Securities of 1<sup>st</sup>. 2<sup>nd</sup> & 3<sup>rd</sup> lowest bides shall be retained till signing of the Contract Agreement with the lowest responsive bidder.
13. All the prevailing KPPRA Act / Rules and other Government Notifications issued will be applicable.
