**TERMS & CONDITIONS:-**

13. Bid Documents Instruction . Condition to bidders can be downloaded up to one day prior to the opening date from C&W web site [www.cwd.gkp.pk](http://www.cwd.gkp.pk). A Complete set of Bid Solicitation Documents may be obtained on submission of a written application one day prior to the opening date from office of the undersigned otherwise bids submitted without these documents will non responsive.
14. Original Bid Security in the shape of Call Deposit in the name of Executive Engineer PBMC C&W Department Peshawar shall accompany the bid.
15. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act 2013 (Khyber Pakhtunkhwa No.XXI of 2013) for works , consulting and Non-consulting services as listed in Schedule-II of the Act ibid.
16. Each bidder shall submit his bid through sealed cover as under:-
  - (c) ORIGINAL and each copy of the bid shall be separately sealed and put in separate envelopes and marked as such.
  - (d) The Envelope containing the ORIGINAL and copies will be put in one sealed envelope and addressed to Executive Engineer PBMC C&W Department Peshawar.
17. As per Khyber Pakhtunkhwa Public Procurement Regulatory Authority No. KPPRA/M&E/Estt:/1-7/2019-20 dated 12.06.2020 the following amendments in SBDs for procurement of Good, Works & Services.
  - iii. In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be sought from the successful bidder only to the Xen: of bid more than 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
  - iv. In such eventually, the successful bidder shall be bound to produce the additional bid security within three (03) working days from the issuance of Letter of Acceptance failing which the bid security of successful bidder shall be forfeited and may also lead to initiate legal proceeding against the bidder who repudiated the contract under 3 KPPRA procurement rules. .
18. The item rate system is replaced by Above/Below system on BOQ based on Market Rate System.
19. Bid will be valid for Ninety (90) days.
20. If the bid rate/cost of two or more than two bidders are same then the successful bid will be decided through toss.
21. All Federal/Provincial duties/Stamp duties/Taxes will be recoverable as per directions of the Government issued from time to time.

22. Execution of Work will be subject to release / availability of fund.
23. The Competent authority reserves the right to reject any or all the tender by assigning the cogent reason in consultation with authority at any time prior to the award of contract.
