- The bidder should be submitted through courier and 2% Security sealed in envelop of the Engineer Estimated in the shape of Call Deposit (Original) before closing date and time.
- As per KPPRA Notification No.1973-85 dated 21<sup>st</sup> of April 2021 that:  
If the contractors quoted their bids more than 10% Below on the Engineer Estimate shall submit an additional Bid Security equal to 8% of the bid cost along with the 2% Bid Security at the time of bid submission.
- Call Deposit of Schedule Banks shall be acceptable and no Bank Cheque or pay order shall be acceptable.
- A copy of Technical Proposal in the required format is mandatory and to uploaded as part of E-Bidding before submitting Financial Bids.
