## GOVERNMENT OF KHYBER PAKHTUNKHWA COMMUNICATION & WOKRS DEPARTMENT. INSTRUCTIONS TO BIDDERS

(Single Stage Single Envelope E-Bidding System)

- 1. Financial proposal should accompany the following.
  - Bid Security 2% of the Estimated Cost in the shape of call deposit in (original) enclosed in financial proposal and no Payment Order will be accepted.
  - b. Enlistment Order of C&W Department (photocopy).
  - c. Renewal of registration for CFY 2020-21 (photocopy).
  - d. National Identity Card (CNIC photo copy).
  - e. Valid Pakistan Engineering Council registration copy for current calendar year.
  - f. Form H of the Company / Firm.
- 2. The award of contract shall be on the basis of above/below engineer estimate on MRS instead of item rate basis.
- 3. The E-Bidders who quote their bids/rates more than 10% below the engineer estimate shell also enclose an additional security in the form of call deposit equal to 8% of the estimated cost in financial proposal.
