TERMS & CONDITIONS:-

1. Bid Documents Instruction . Condition to bidders can be downloaded up to one day prior to the opening date from C&W web site www.cwd.gkp.pk. A Complete set of Bid Solicitation Documents may be obtained on submission of a written application one day prior to the opening date from office of the undersigned otherwise bids submitted without these documents will non responsive.
2. Original Bid Security in the shape of Call Deposit in the name of Executive Engineer PBMC C&W Department Peshawar shall accompany the bid.
3. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act 2013 (Khyber Pakhtunkhwa No.XXI of 2013) for works , consulting and Non-consulting services as listed in Schedule-II of the Act ibid.
4. Each bidder shall submit his bid through sealed cover as under:-
 - (e) ORIGINAL and each copy of the bid shall be separately sealed and put in separate envelopes and marked as such.
 - (f) The Envelope containing the ORIGINAL and copies will be put in one sealed envelope and addressed to Executive Engineer PBMC C&W Department Peshawar.
5. Additional bid security i.e 8% shall be received as per Khyber Pakhtunkhwa Public Procurement Regulatory Authority Notification No.. S.R.O (12) / Vol-II/1-20/2020-21/ 2973-85 dated 21.04.2021 the following amendments in SBDs for procurement of Good, Works & Services.
 - i. In case of bid/rate quoted by the bidder more than 10% below engineer estimate, shall submit an additional bid security equal to 8% of the bid cost alongwith the 2% bid security at the time of bid submission.
 - ii. if the successful Contractor how has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the contract, the entire security deposit i.e that is 2% bid security alongwith 8% additional bid security shall be forfeited in favour of the Government.
 - iii. if the successful contractor how has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the contract for three different time in different bids during the same fiscal year, then the entire security deposit i.e (2+8)% shall be forfeited in the favour of the Government and the Contractor shall also be proceeded for blacklisting for period of 05 years.
6. The item rate system is replaced by Above/Below system on BOQ based on Market Rate System.
7. Bid will be valid for Ninety (90) days.
8. If the bid rate / cost of two or more than two bidders are same then the successful bid will be decided through toss.
9. All Federal/Provincial duties/Stamp duties/Taxes will be recoverable as per directions of the Government issued from time to time.
10. Execution of Work will be subject to release / availability of fund.
11. The Competent authority reserves the right to reject any or all the tender by assigning the cogent reason in consultation with authority at any time prior to the award of contract.
