**(Single Stage Single envelop procedure)**

C&W Department Highway Division Swat Government of Khyber Pakhtunkhwa invites sealed Bids from eligible firms / Contractor in accordance with KPPRA Procurement Rules 2014 on single stage single envelop procedure for the following works. The bidders should be registered with Pakistan Engineering Council (PEC 2019) in relevant category and field of specialization, enlisted with C&W Department and should have adequate financial soundness, relevant experience, personnel capabilities, require equipment and others as included in ITB.

- Bid documents including Tender Form, BOQ and instruction to bidders can be downloaded up to one day prior to the opening date from C&W web site ([www.cwd.gkp.pk](http://www.cwd.gkp.pk)).
- All bidders are required to register with Khyber Pakhtunkhwa Revenue Authority, Established under Khyber Pakhtunkhwa Finance Act 2013 (Khyber Pakhtunkhwa XXI of 2013) for works consulting and Non consulting services as listed in Schedule – II of the Act ibid.
- According to KPPRA Notification issued vide S.R.O (12)/Vol: 1-20/2020-21/1923-85, dated: 21.04.2021.
  - The Contractors quoting their bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security equal to 8% of the Bid Cost along with the 2% bid security at the time of bid submission.
  - If the Successful Contractor who has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the Contract, the entire Security Deposit i.e. 2% bid Security alongwith 8% Additional Bid Security shall be forfeited in favour of the Government.
  - The Successful Contractor who has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the Contract for three times in different bids during the same fiscal year, then the entire Security Deposit i.e. (2 + 8) % shall be forfeited in favour of the Government and the Contractor shall also be proceeded for black listing for a period of Five Years.
- Original Bid Security in the shape of call deposit in the name of Executive Engineer C&W Highway Division Swat shall accompany the financial bid.
- Bidder who submitted their financial bids without a valid Call Deposit will be debarred from participating in bidding process for one year.
