Bid documents and instruction to bidders can be downloaded from C&W web site (www.cwd.gkp.pk) before the submission date/time.

- Bid security 2% of the estimated cost in shape of call deposit (in Original) should be enclosed along with bidding documents.
- The contractors quoting their bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security equal to 8% of the bid cost along with the 2% bid security at the time of bid submission.
- If the successful contractor who has quoted a rate more than 10% below on the Engineer's Estimate and has repudiated the contract, the entire security deposit i.e. 2% bid security along with 8% Additional Bid Security shall be forfeited in favour of the government.
- If the successful contractor who has quoted a rate more than 10% below on the Engineer's Estimate and has repudiated the contract for 3 different times in different bids during the same fiscal year, then the entire security deposit i.e. (2+8)% shall be forfeited in the favour of the government and the contractor shall also be proceeded for blacklisting for a period of 5 years.
- The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids and the market analysis in order to discourage cartel making and to protect public interest at large.
- The bidder must be enlisted with the Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
- Pay Order is not acceptable as per Notification No. of KPPRA vide No. KPPRA/M&E/Estt:/1-12/2017-18, dated: 05/04/2018.
- Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bids.
- The Khyber Pakhtunkhwa Finance Act XXVII of 2019 2nd Schedule under S.No.14, in case of projects funded under the Government's ADP Budget, Tax shall be charged at the rate of Two Percent (2%).
- Venue of bids opening is office of the Executive Engineer, Highway Division Bannu.
