1. Bid documents and instructions to bidders can be downloaded from C&W web site (www.cwd.gkp.pk) before submission date / time and bidder shall follow conditions of SBDs.
2. All bidders are required to register with Khyber Pakhtunkhwa Revenue Authority, Established under Khyber Pakhtunkhwa Finance Act 2013 (Khyber Pakhtunkhwa XXI of 2013) for works consulting and Non consulting services as listed in Schedule – II of the Act ibid.
3. A Copy of the Technical Proposals in the required format is mandatory and to be uploaded as part of E-Bidding before submitting Financial Bids.
4. According to KPPRA Notification issued vide S.R.O (12)/Vol: 1-20/2020-21/1923-85, dated: 21.04.2021.
 - i. The Contractors quoting their bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security equal to 8% of the Bid Cost along with the 2% bid security at the time of bid submission.
 - ii. If the Successful Contractor who has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the Contract, the entire Security Deposit i.e. 2% bid Security alongwith 8% Additional Bid Security shall be forfeited in favour of the Government.
 - iii. The Successful Contractor who has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the Contract for three times in different bids during the same fiscal year, then the entire Security Deposit i.e. (2 + 8) % shall be forfeited in favour of the Government and the Contractor shall also be proceeded for black listing for a period of Five Years.
5. Scanned Copy of Bid Security shall be submitted electronically along with Technical Bid on E-Bidding System.
6. Venue of Bids opening is "Office of the Executive Engineer C&W Highway Division at Saidu Sharif Swat".
