 - a) Technical & Managerial Staff Bio-Data along with supporting documents.
 - b) Detail of similar nature of works completed supported by completion certificates and work orders of concerned executing agency.
 - c) Detail of similar work and amount in hand.
 - d) Detail of related T&P and Machinery alongwith supporting documents.
 - e) Registration with PEC in respective category alongwith relevant codes duly renewed upto 30.06.2021.
 - f) Registration with C&W Department Government of Khyber Pakhtunkhwa duly renewed upto 30.06.2021.
 - g) Financial Status for last three years including bank statement and audit reports prepared by Quality Control Review (QCR) listed Auditors.
 - h) Income Tax Certificate and KPRA Registration.
 - i) Location of Head /Area Office.
 - j) An affidavit Stamp Paper in original (of current month / year) to effect that there is no dispute/litigation of the firm with any department.
 - k) Bid submitted by Joint Venture of two or more firms as partners are not allowed.
3. Application of firms, black listed by any Government Agencies will not be considered for pre-qualification. If the constructors/ firms supply incorrect/false information documents, they shall be recommended to higher authorities for disqualification, if found at any stage punitive action will be taken accordingly.

Eligible applicants may obtained pre-qualification/technical evaluation documents containing guidelines and criteria at the cost of Rs.5000/- Cash for each work (non-refundable) from office of the M/S PEPAC Consultants (Pvt.)
