NOTICE INVITING TENDERS
(Single stage two envelope procedure)

1. C & W Department (**Highway Division Bannu**), Government of Khyber Pakhtunkhwa invites sealed Bids from eligible firms /contractor in accordance with KPPRA procurement rules 2014 on single stage two envelope procedure for the following works. The Bidders should be registered with Pakistan Engineering Council (PEC) in relevant category & field of specialization, enlisted with C&W Department and should have adequate financial soundness, relevant experience, personnel capabilities, require equipment and others as included in ITB.

INSTRUCTIONS TO BIDDERS

(KPPRA Single stage two envelop bidding procedure)

1. Technical bid/ proposal should accompany the following:
 - a. Certificate that that Bid Security in the shape of Call deposit (original) has been enclosed in financial bid.
 - b. Enlistment Order of C&W Department (photocopy).
 - c. Renewal of registration for CFY 2021-22 (Photocopy).
 - d. National Identity Card (CNIC Photocopy).
 - e. Pakistan Engineering Council registration copy for calendar year 2021-22.
 - f. Form H of the Company / Firm.
 - g. Documents showing general capabilities, financial soundness, general and relevant experience record, personnel capabilities, equipment capabilities and Income Tax / NTN Certificates.
 - h. Any other document to support the technical bid.
 - i. The bidder must have executed the mega road work at least 60% of contract amount.
2. Technical evaluation will be carried out on marks threshold in passing all the fields including PEC Registration, Enlistment with C&W Deptt., Tax Payer proof, Relevant experience in past 05 years, Performance, Technical Personnel, required Equipment, Financial status, Auditors report, Managerial capabilities, Litigation status etc.
3. Incomplete/ Conditional / Electronic bids and bids received after closing time shall not be entertained. Bids shall be signed by authorized persons.

4. Bid security 2% of the estimated cost in shape of call deposit (in Original) should be enclosed along with bidding documents.
5. The contractors quoting their bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security equal to 8% of the bid cost along with the 2% bid security at the time of bid submission.
6. If the successful contractor who has quoted a rate more than 10% below on the Engineer's Estimate and has repudiated the contract, the entire security deposit i.e. 2% bid security along with 8% Additional Bid Security shall be forfeited in favour of the government.
7. If the successful contractor who has quoted a rate more than 10% below on the Engineer's Estimate and has repudiated the contract for 3 different times in different bids during the same fiscal year, then the entire security deposit i.e. (2+8)% shall be forfeited in the favour of the government and the contractor shall also be proceeded for blacklisting for a period of 5 years.
8. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids and the market analysis in order to discourage cartel making and to protect public interest at large.
9. Any bidder who provides incorrect information, fake documents should be disqualified.
10. Time allowed for completion of the work is as specified in the NIT which will start from the issuance of work order.
11. Bids will be valid for Ninety (90) days.
12. Successful Bidder should sign the agreement with the department within stipulated time after acceptance of bid.
13. Call Deposit of Scheduled Banks shall be acceptable.
14. If the evaluated bid costs of two or more than two bidders are same then the successful bid will be declared through draw.
15. A copy of the technical proposals in the required format is mandatory and to be uploaded as a part of E-Bidding before submitting Financial Bids.
16. Scanned copy of bid security i/c Tender Entry Fee shall be submitted electronically along with technical bid on E-Bidding System.
17. Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bids.
18. The bidder must be enlisted with the Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
19. Pay Order is not acceptable as per Notification No. of KPPRA vide No. KPPRA/M&E/Estt:/1-12/2017-18, dated: 05/04/2018.
20. The Khyber Pakhtunkhwa Finance Act XXVII of 2019 2nd Schedule under S.No.14, in case of projects funded under the Government's ADP Budget, Tax shall be charged at the rate of Two Percent (2%).
21. Venue of bids opening is office of the Executive Engineer, Highway Division Bannu.

Note:- It is mandatory to all contractors, who are participating in the bidding should sign every page of their broacher with page numbering and mentioning here total No. of Pages i.e. 1 of 200 before submitting in the office of the undersigned, unsigned broacher will not be considered in the bidding process.
