- Bid Security 2% of the Estimated Cost in the shape of call deposit in (original) enclosed along-with bidding documents. The E-Bidders who quote their bids/rates more than 10% below the engineers estimate shall also enclose an additional security in the form of Call Deposit equal to 8% of estimated cost in bidding documents.
- The Technical and Financial bids should be enclosed in separate envelopes alongwith a copy of each; and marked according to KPPRA rules. The Technical Bid should include Bid entry fee 0.03% of the Estimated Cost in the shape of call deposit in original, which is nonrefundable. Otherwise the bids will not be evaluated and returned to the bidder.
- The Bidder should have the relevant PEC specialization code, without which the bid will not be acceptable.
- A Pre-Bid is scheduled on 31.08.2021 at 11:00 am in the office of the Executive Engineer C&W Division Mega Projects South-I at Kohat
- Financial bid of only technically qualified bidders will be opened after approval from the competent authority.
- All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services a listed in Schedule-II of the Act ibid.
