



- 1- The Executive Engineer Upper C&W Division Kurram, invites sealed Bids from the eligible firms/bidders/Manufacturers/authorized Dealers registered in relevant code: in accordance with KPPRA procurement Rules 2014 and registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013) and who have renewed their registration for the year 2021-22 and also register with Pakistan Engineering Council with specialized code for the year 2021-22, visible on Website of PEC, on Single Stage Single Envelop procedure for the following work: -

INSTRUCTIONS TO BIDDERS

(Single Stage Single Envelop E-Bidding System)

1. Financial proposal should accompany the following:
 - a. Bid Security 2% of the Estimated Cost in the shape of call deposit in (original) enclosed in financial proposal.
 - b. The Contractors quoting their bids more than 15% below shall submit an Additional Bid Security equal to extent of their bid/rates more than 15% below on Engineering estimate along with the 2% bid security at the time of bid submission.
 - c. If the successful contractor who has quoted a rate more than 15% below on the Engineer Estimate and has repudiated the contract, the entire security deposit i.e. 2% bid security along with additional security shall be forfeited in favour of the Government.
 - d. If the successful contractor who has quoted a rate more than 15% below on the Engineer Estimate and has repudiated the contract for three different times in different bids during the same fiscal year, then the entire security deposit i.e. 2% and additional security shall be forfeited in the favour of the Government and the Contractor shall also be proceeded for blacklisting for a period of five years.
 - e. Enlistment Order of C&W Department (photocopy)
 - f. Renewal of registration for CFY 2021-22 (Photocopy)
 - g. National Identity Card (CNIC Photocopy)
 - h. Valid Pakistan Engineering Council registration copy for current calendar year.
 - i. Form H of the Company / Firm.
2. After commencement of work by the successful bidder, the additional security shall be released to the bidders in four installments i.e. 25% to be released after completing 25% of the project and so on. In case the bidder quotes lower than 15% below the Engineer's Estimate and the bid is not accompanied by an additional bid security then bid shall be considered as non-responsive.
3. All the bidding will be through E-bidding system. Bid should be in sealed envelopes and shall be submitted through courier before closing time.
4. In case a contractor quotes more than 30% below on Engineer Estimate, the procuring entity shall, in addition to additional security, Require the contractor to produce detailed rate analysis of his bid price in relation to any or all the items of bill of quantities, scope of work, allocation of risks and responsibilities and/or any other requirements of the bid solicitation document. The contract shall be awarded to the lowest evaluated bidder who has satisfied the procuring entity on rate analysis. However, if the procuring entity determines that the contractor has failed to demonstrate its capability to execute the contract at the offered price, the matter shall be referred to the next higher authority for rejection of the bid on the basis of being financially unviable.
5. The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as non-MRS items.
6. Bid shall be filled online. Complete bid must reach the concerned offices on or before the fixed date/ time. The CDR or Additional Security (if required) shall be enclosed in the Bid Proposal.
7. Any Electronic Bidder who provides incorrect information shall stand disqualified & de-barred.
8. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of LOA.
9. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013(Khyber Pakhtunkhwa Act No. XXI of 2013), for works consulting & non-consulting services as listed in Schedule-II of the Act ibid.
10. Electronic Bids validity period is 90 days.
11. Successful Bidder should sign the agreement with the department within (28) days after issuance of LOA.
12. Call Deposit of Scheduled Banks shall be acceptable.
13. The submission of CDR by the contractor will be mandatory along with a verified copy of CDR from the concerned Bank should be provided with the Bid Proposal.
14. If the evaluated electronic bid costs of two or more than two bidders are equal, then the successful bid will be declared through draw.
15. Bid will be opened after 30 minutes of closing time in the presence of bidders/ their representatives who choose to be present.
16. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
17. Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bid.
