- As recommended by Sub Committee of the Cabinet notified vide Section Officer (Confidential) Chief Minister's Secretariat Khyber Pakhtunkhwa Peshawar No. SO(C)/CMS/KPK/2021/2828-21 Dated: 05.04.2021. Non Refundable Bidding Entry fee @0.03% of Tender Cost alongwith 02% Earnest Money and stamp Duty separately (In Original) should accompany the financial Bid.
- The bidders should be enlisted with Khyber Pakhtunkhwa Revenue Authority as per KPPRA Rules.
- A copy of the technical proposals in the required format is mandatory and to be uploaded as part of E-Bidding before submitting financial bids.
- Venue of Bid opening is C&W Division Hangu.
- The Contractors quoting their bids upto a limit of 15% below on Engineer's Estimate shall submit bid security to the extent of 2% of Engineer's Estimate only.
- The Contractors quoting their bids more than 15% below on Engineer's Estimate shall submit alongwith their bids an **Additional Security to the extent of their bid / rates more than 15% below on Engineer's Estimate in the form of percentage.**
- In case the bidder quotes more than 15% below the Engineer's Estimate and the bid is not accompanied by the Additional Security then the bid shall be considered as non-responsive and the 2nd lowest bidder and so on will be considered accordingly.
- In case a Contractor quotes more than 30% below on Engineer Estimate, the procuring entity shall, in addition to Additional Security, require the Contractor to produce detailed rate analysis of his bid price in relation to any or all the items of bill of quantities, scope of work, allocation of risks and responsibilities and / or any other requirements of the bid solicitation document.
