

Tender Form can be obtained from office of the Deputy Director (HQ) PKHA before the closing date during working hours. The bidders are required to submit their bid in lump-sum amount (without taxes). Sealed bids including Tender Form are required to be sent through postal UMS/Courier **upto 12:00 noon of 22/01/2024**, which will be opened on the same day at 12:30 P.M in the presence of the participants or their representatives. The bidders are required to send their bids in duplicate in separate sealed envelopes clearly marked as Original & Duplicate. The Original shall be sent to the Deputy Director (HQ) PKHA and the Duplicate to Director - I PKHA. Both the Original and Duplicate bids shall reach the concerned office before closing date and time. Other terms and requirements are described below:

1. Attested copy of the National Identity Card of the bidder or his authorized representative will be provided with the bid.
2. Bidder will provide Active Taxpayer Certificate with their bid.
3. The bid security @2% of the bid amount in shape of Call Deposit (CDR) to be issued from any Schedule Bank of Pakistan, (and to be payable from the said Bank Branch in Peshawar), **in favour of the Managing Director PKHA** Peshawar shall be provided with the bid.
4. Security will be refunded after 15 days of completion of the work.
5. Successful bidder shall be required to deposit 1/4<sup>th</sup> of the auction money (in form of CDR) on the bid opening day till closing hours, while the balance amount shall be paid within three days of the acceptance of the auction, failing which 2% Bid Security and 1/4<sup>th</sup> auction money shall stand forfeited.
6. The Successful bidders shall obtain NOC / clearance certificate from Finance Section of PKHA for payment of all admissible taxes including stamp duty, service charges, sale tax and any other taxes at prevailing rate before shifting the material from the sites. **It is worth mentioning that the amount of taxes will be paid by the successful bidder in addition to the quoted bid.**
7. The competent authority reserves the right to reject anyone or all bids assigning cogent reasons.
